A. WV Capital Access Program Update

Mr. Polk updated the Board on the progress of the SSBCI WVCAP Program. He informed the Board that the WVCAP update that is in their board packages has been updated through the end of July. He informed the Board that as of July 31st, that thirty-one transactions have been approved and 262 jobs have been created, 232 have been retained, and that there are CAP transactions in 16 counties in WV.
