Vice Chairman Wilmoth confirmed a quorum and called the meeting to order. The agenda for the meeting and action taken consisted of the following:

I. MINUTES

A motion was made by Mr. Hartley to approve the minutes of the November 16, 2023 meeting of the WVJIT. The motion was seconded by Mr. Irby and unanimously carried.

II. TREASURER'S REPORT

A motion was made by Mr. Bohman to approve the WVJIT treasurer's report for December 31, 2023. The motion was seconded by Mr. Irby and unanimously carried.

III. EXECUTIVE SESSION

Mr. Ritchie made a motion to move the Board into executive session to consider certain matters involving confidential, commercial, financial, and/or personal information relating to investments or prospective investments of the West Virginia Jobs Investment Trust, pursuant to West Virginia Codes §12-7-11 and §6-9A-4." The motion was seconded by Mr. Hartley and unanimously carried.

IV. RETURN TO GENERAL SESSION

A motion was made by Mr. Bohman to return to general session. The motion was seconded by Mr. Irby and unanimously carried.

V. RealX, Inc. Follow-On Investment Proposal

Executive Director Zulauf gave an overview of the RealX, Inc. Follow-On Investment Proposal for \$500,000 and answered questions from the Board. A motion was made by Mr. Ritchie to approve the presented proposal. The motion was seconded by Mr. Hartley and unanimously carried.

VI. WVCAP Marketing Proposal from Mountain Craft Productions, Inc. Consideration

Executive Director Zulauf gave an overview of the Mountain Craft Productions, Inc. marketing proposal and answered questions from the Board. A motion was made by Mr. Hartley to approve the presented proposal. The motion was seconded by Mr. Ritchie and unanimously carried.

VII. OTHER BUSINESS

Mr. Polk updated the Board on the progress of the SSBCI WVCAP Program. He informed the Board that the WVCAP update that is in their board packages has been updated through the end of December. He informed the Board that as of December 31st, 59 transactions have been approved, representing 374 created jobs and 965 retained jobs across 23 counties in West Virginia.
