# REGULAR MEETING OF WV CAPITAL ACCESS PROGRAM COMMITTEE

## December 19, 2023

A meeting of the West Virginia Capital Access Program Committee (WVCAP) was held by teleconference on Tuesday, December 19, 2023 at 1:15 p.m. at the WV Economic Development Authority located at 180 Association Drive, Charleston, WV. The meeting was called to order at 1:18 p.m. A quorum was confirmed. Those participating were:
