REGULAR MEETING OF WV CAPITAL ACCESS PROGRAM COMMITTEE

March 26, 2024

A meeting of the West Virginia Capital Access Program Committee (WVCAP) was held by teleconference on Tuesday, March 26, 2024 at 1:00 p.m. at the WV Economic Development Authority located at 180 Association Drive, Charleston, WV. I. APPROVAL OF ACTION TAKEN AT AND MINUTES OF FEBRUARY 20, 2024 REGULAR MEETING

IV. WVCAP UPDATE REPORT

Mr. Polk updated the Committee on the progress of pending WVCAP applications. He noted for the Board the account balances on the WVCAP Update report, as well as mentioning the jobs retained, jobs created, and counties listed in the report. He informed the Committee that WVCAP has approved 72 transactions, creating 415 jobs, retaining 1,012 jobs, and covering 26 counties.
