REGULAR MEETING OF WV CAPITAL ACCESS PROGRAM COMMITTEE

September 24, 2024

A meeting of the West Virginia Capital Access Program Committee (WVCAP) was held by teleconference on Tuesday, September 24, 2024 at 1:00 p.m. at the WV Economic Development Authority located at 180 Association Drive, Charleston, WV. A quorum was confirmed. Those participating were:

The meeting and action taken consisted of the following:

I. APPROVAL OF ACTION TAKEN AT AND MINUTES OF AUGUST 20, 2024 REGULAR MEETING AND MINUTES OF AUGUST 30, 2024 SPECIAL MEETING

The approval of the August 20, 2024 and August 30, 2024 minutes were introduced to the Committee for approval. There were no questions or objections.

II. <u>EXECUTIVE SESSION</u>

Mr. Johnson seconded the motion, and the motion carried. The Committee entered executive session at 1:03 p.m.

The Committee reconvened into regular session at 1:19 p.m. No action was taken during executive session.

UPDATE - EATS! LLC Application from August 20, 2024

Mr. Polk confirmed the requirements of the conditional approval for EATS! LLC from the August 20, 2024 WVCAP Committee Meeting were met after receipt of satisfactory documentation from Woodlands Community Lenders.

IV. WVCAP UPDATE REPORT

Mr. Polk updated the Committee on the progress of pending WVCAP applications. He noted for the Committee that account balances on the WVCAP Update report, as well as mentioning the jobs retained, jobs created, and counties listed in the report. He informed the Committee that WVCAP has approved 97 transactions, creating 505 jobs, retaining 1,316 jobs, and having WVCAP transactions in 27 counties.

Ms. Myers gave a general update to the Committee on the Technical Assistance Program, with Partner Community Capital expected to provide more data in the coming months.

V. OTHER BUSINESS AND ADJOURNMENT

The Chairman noted the next WVCAP Committee meeting is scheduled for October 22, 2024, at 1:00 p.m.
