Chairman Pack confirmed a quorum and called the meeting to order. The agenda for the meeting and action taken consisted of the following:

## I. MINUTES

A motion was made by Mr. Hartley to approve the minutes of the August 15, 2024 meeting of the WVJIT. The motion was seconded by Ms. Olejasz and unanimously carried.

## II. TREASURER'S REPORT

A motion was made by Mr. Irby to approve the WVJIT treasurer's report for September 30, 2024. The motion was seconded by Ms. Dunn-Marshall and unanimously carried.

## III. <u>EXECUTIVE SESSION</u>

Mr. Hartley made a motion to move the Board into executive session to consider certain matters involving confidential, commercial, financial and/or personal information relating to investments or prospective investments of the West Virginia Jobs Investment Trust, pursuant to West Virginia Codes §12-7-11 and §6-9A-4. The motion was seconded by Mr. Irby and unanimously carried.

### IV. RETURN TO GENERAL SESSION

A motion was made by Mr. Hartley to return to general session. The motion was seconded by Ms. Dunn-Marshall and unanimously carried.

## A. Approval of Spilman, Thomas, and Battle Proposal for Outside Legal Counsel

Executive Director Andrew Zulauf reviewed the proposal with the Board. A motion was made by Mr. Irby to approve the proposal. The motion was seconded by Mr. Hartley and unanimously carried.

#### V. OTHER BUSINESS

## A. WV Capital Access Program Update

Mr. Adkins updated the Board on the progress of the SSBCI WVCAP Program. He informed the Board that as of September 30, 2024, 97 transactions have been approved, representing 505 jobs created, and 1,316 jobs retained across 27 counties in West Virginia. Mr. Adkins also discussed various SSBCI reports and applications that WVJIT is undertaking, including the 3<sup>rd</sup> Quarter Report, Semi-Annual Technical Assistance Report, and Capital Disbursement Request Application.

## VI. ADJOURN

There being no further business, Ms. Olejasz made the motion to adjourn. Mr. Irby seconded the motion and without objection, the Chairman declared the meeting adjourned.
