# A. WV Capital Access Program Update

Mr. Adkins updated the Board on the progress of the SSBCI WVCAP Program. He informed the Board that as of June 9, 2025, 114 transactions have been approved, representing 714 jobs created and 1,317 jobs retained across 28 counties in West Virginia. Mr. Adkins also informed the Board that WVJIT is working on the third disbursement and capital allocation request to the U.S. Treasury.
